## **The procedure for joining the International Union for Military-Applied Sports and termination of its membership.**

### **1. General provisions.**

1.1. This Procedure has been developed in accordance with the Civil Code of the Republic of Kazakhstan, the Laws of the Republic of Kazakhstan: "On Public Associations", "On non-profit organizations", "On self-regulation", "On Physical Culture and Sports" and other legislative acts of the Republic of Kazakhstan, the Charter of the International Union for Military-Applied Sports.

### **2. Requirements for members of the International Union for Military-Applied Sports.**

- 2.1.** Members of the International Union for Military-Applied Sports (hereinafter referred to as the "Union") may be persons who recognize and comply with the Rules of the "Union", the Charter, documents and the resolutions of the "Union", in particular, the members of the "Union" may be:
- National organizations for military-applied sports that unite legal entities and individuals interested in the development of military-applied sports in a given country and coordinate the development of all varieties and types of this sport in a given country. The Union recognizes from each country only one National Organization for military-applied sports, which has the status of a legal entity and is recognized by the highest body governing the field of sports in this country;
  - Various legal entities.
- 2.2.** National organizations for military-applied sports and other organizations of the country in which discrimination exists or where discrimination is permitted by their law, if they have been previously accused of crimes, in accordance with international and/or national laws of the countries of the world, are not allowed to join the "Union";
- 2.3.** Members of the "Union", by virtue of their membership, are official representatives of the "Union", contributing to the implementation of the goals of the "Union" on the ground;
- 2.4.** A candidate for membership of the "Union" must submit for consideration to the Executive Board "Union" written application for membership in the "Union" in the form standardized according to the charter of the "Union";
- 2.5.** The Executive Council of the Union considers the application and makes a decision on admission to membership or refusal, which must be submitted to the applicant no later than one month from the date of submission of the application; The date of adoption by the Executive Council of the Union of the decision on admission of the applicant is the date of his admission. The decision of the Executive Council of the Union is subject to approval by the Congress.
- 2.6.** The "Union" maintains a register of members of the "Union". Information about the members of the "Union" must contain the name and location of each member of the "Union", data about its leader. The register should also reflect cases of suspension of membership and exclusion of members from the "Union";
- 2.7.** The members of the "Union" are obliged to promptly notify the "Union" of all changes to their data in the register;

**2.8.** Documents and resolutions adopted by the members of the "Union" must comply with the Charter, documents and resolutions of the "Union";

**2.9.** The Union equally respects the rights and interests of all members of the Union, represents them in other organizations and protects their interests and rights in them;

**2.10.** Members of the "Union" and any persons involved in military-applied sports can use the services of Sports Agents recognized by the "Union". The procedure for registration of Agents, their rights and obligations, as well as the procedure for reviewing contracts (treaties) and other documents with their participation are determined in accordance with the conditions and requirements established by the Union;

### **3. Admission to the membership of the Union.**

**3.1.** Candidates (applicants) for membership in the "Union" must, by the time of submitting an application for membership in the "Union", familiarize themselves with the Charter of the "Union", the procedure for admission to membership in the "Union", with the requirements established by the "Union" for its members, internal documents, as well as with the procedure for paying membership fees. The specified information is posted by the Union on its electronic website in the information and telecommunications network "Internet" - the website:

**3.2.** Candidates (applicants) for membership of the "Union" must attach to the application for membership of the "Union":

**Appendices:** a certified copy of the decision (protocol) on joining the International Union for Military-Applied Sports; an extract from the Unified State Register of Legal Entities; a copy of the Charter with a note on registration with a state body, certified and sealed by a public organization; a completed Registration card (form on the website); a copy of the payment document on the transfer of the entrance fee (when the Executive Council of the "Union" makes a positive decision on the admission of the applicant for admission to the membership of the "Union").

**3.3.** The application for membership in the "Union" is filled out in the personal presence of the applicant for membership in the Union, or is certified by a notary by confirming the identity with a notary and then signing the application with a signature certificate.

**3.4.** After receiving the application for membership of the Union and its annexes (clause 3.2.), the Executive Council of the Union considers the application and decides on membership or refusal, which must be submitted to the applicant no later than one month from the date of submission of the application; The date of acceptance by the Executive Council of the Union the decision on the applicant's admission is the date of his admission. The decision of the Executive Council of the Union is subject to approval by the Congress. A candidate is considered accepted as a member of the "Union" from the date of approval of his membership by the Congress  
"Union".

**3.5.** A member of the Union is issued a document confirming membership in the "Union".

**3.6.** Information about the members of the "Union" is posted on the Website of the "Union" on the Internet - the website:

**3.7.** In case of a decision to refuse admission, the Union sends a written refusal to the candidate without explaining the reasons.

### **4. The procedure for termination of membership in the Union.**

#### **4.1. Termination of membership in the Union occurs:**

- in view of actions contrary to the Charter, resolutions and documents of the "Union", their non-performance, their non-compliance and/or their violations;
- in case of loss of legal status, death, withdrawal or exclusion from the "Union". In case of withdrawal, an individual or an organization wishing to withdraw from the "Union", submits an application for withdrawal in writing. The withdrawal takes effect 90

days after the receipt of the application to the headquarters of the "Union". If the member is has not fulfilled his/her duties as a member stipulated by the Charter, including financial obligations to the Union, his/her application for withdrawal is reserved by the headquarters of the Union until he/she fulfills his/her duties, and after that the member will have to submit an application for withdrawal again, which takes effect 90 days after it is received by the headquarters "Of the Union" and must be finally confirmed by the Congresses. An application for withdrawal by an organization is recognized only after it has been signed by more than three-quarters of the members of its Executive Board.

- in view of the refusal to comply with the decisions of the "Union";
- in view of rude attacks against the "Union" or any of its bodies or members;
- due to the constant violation of the terms of payment of membership and other fees and payment and/or non-payment of debts to the "Union";
- due to voluntary withdrawal from membership or termination of its activities;
- Decisions on termination of membership made by the Union may be suspended, canceled or changed only by the decision of the Union itself;
- non-payment of arrears on membership fees within one month from the date of the decision to suspend membership;
- disclosure of confidential information, including banking, insurance, official, commercial and other secrets protected by law, about the activities of the "Union" and members of the "Union";
- In any case, when a member of the "Union" refuses to fulfill its obligations under the Charter, does not fulfill its financial obligations under this Charter or harms the interests of the "Union" or harms dignity of the "Union"; the Executive Council of the "Union" may decide to expel this member. This exception will come into force by decision of the Executive Board of the "Union"; in this case, the excluded person is immediately suspended from all statutory rights and activities. The Union's Executive Council will include the suspension sanction on the agenda of the next Congress. The upcoming Congress must approve or reject an exclusion sanction against a member.

### **Final provisions.**

3.2. This Procedure comes into force from the date of its approval by the Congress of the "Union".
